# REBUILDING HOMES AND ENABLING RECOVERY

In 2020, Category 5 Tropical Cyclone Harold wiped away homes and villages in Vanuatu leaving 87,000 people without shelter.



Risa is a wife and mother of three living on Pentacost Island, one of the more rural islands in Vanuatu. When Tropical Cyclone Harold hit, it destroyed much of Risa's home and many of her family's possessions.

She said, "When we heard that the cyclone is coming, we managed to tie the palm leaves over the house to protect the roofs. Unfortunately, all those had been blown down when the cyclone hit."

When the wind picked up, Risa and her family moved to the school along with other residents. She says, "We just stood there. I was with my one-year-old grandson. We were just leaning against

the wall. Luckily I moved away before the branch came down onto the wall. In the morning, everyone, especially the mothers, just cried. They had lost most of their belongings, especially the houses and their clothes."

Although this was in the middle of COVID, ShelterBox, working with our in-country partners, provided tarpaulins and tools to make repairs along with a kitchen set and solar lights.

According to Risa, "With all these materials and supplies that have been given, it has helped us a lot. I have had mothers who dance with joy when they open the packages."

I want to take this opportunity to say thank you for taking the initiative to come all the way here as we don't always have people who are concerned about the life of our people.

Thank you so much to the aid donors and everyone who has contributed in one way or another to help us come back slowly to the normal life.

When the bombs started falling in Ukraine, ShelterBox was in Poland within days working with our Rotary partners and other humanitarian organisations to determine what would be needed for those displaced by the conflict.

Thanks to our generous supporters, we were able to quickly supply mattresses for people in transit who were sleeping on the cold floor of collective centres.

We provided ShelterKits with tarpaulins, tools, thick thermal blankets, solar lights and water carriers, stoves and firewood to those whose homes had been damaged or destroyed to keep them warm and safe.

And we provided hygiene kits, warm coats and a small amount of cash assistance to those who left through the border with Moldova to help them with food and shelter as they made their way to safe havens.

We anticipte being in Ukraine until the conflict ends.



# FREQUENTLY ASKED **QUESTIONS**

Leaving a gift in your Will to ShelterBox is simple and helps create a world where no one is without shelter after disaster.

Wills are designed to ensure your wishes are carried out after you are gone.

This booklet has been designed to assist you in leaving money to ShelterBox in your Will. It does not constitute legal or tax advice.

If you have questions about creating a new Will or updating a Will, you should seek advice from a qualified professional, such as a lawyer.

#### DO I NEED A WILL?

Having a Will is the best way to make sure your wishes are carried out, and is an act of loving care towards your family and any other named beneficiaries. A will can bring calm and reassurance at a time of grief and stress.

#### WHAT IF I DON'T HAVE A WILL?

In New Zealand, if your estate includes a single asset worth \$15,000 or more and you don't have a Will, your estate will be divided according to the law of intestacy amongst family members depending on which family members survive you. If there are no remaining family members, your assets will transfer to the New Zealand Crown unless you have a Will.

#### CAN I WRITE MY OWN WILL?

We strongly recommend using a qualified lawyer, as any errors in a Will can cause problems or make it invalid.


If you don't have a lawyer, ShelterBox New Zealand has partnered with online Will-writing platform <u>Footprint</u> and can offer you a 15% discount with the code SHELTERB.

#### WHAT IF I ALREADY HAVE A WILL?

You can create and sign a Codicil to change your existing Will by downloading <u>this form</u>. You can instruct your lawyer to update your existing Will for you.

# DO I NEED TO LET SHELTERBOX KNOW I'VE GIVEN A GIFT IN MY WILL?

We do hope you'll let us know. Not only will it help us plan for the future, but we would love the opportunity to say "thank you" and keep you updated with the amazing work ShelterBox does to help the most vulnerable people. However, we understand if you wish to remain anonymous.



### **WAYS TO GIVE**

### Take care of your loved ones first!

After that, a gift in your Will may be:

A residual bequest. This means that after all specific gifts are distributed to the beneficiaries named in the Will and your debts are paid, the remainder, or a portion of the remainder will be gifted to ShelterBox. This is a popular choice as it automatically adjusts to changes in the value of your estate.

A specific amount or item. This means that you want to leave a specific sum of money or an item or items of value to ShelterBox in your Will.

**Family trusts.** If your assets are already in a family trust, then the best way to support ShelterBox is to include us in the memorandum of wishes and make sure that ShelterBox is (or can be added as) a Beneficiary under the terms of the Trust.

Talk to your lawyer about the type of gift that will best suit you and your estate. Remember, gifts left to charities in Wills are exempt from inheritance and capital gains taxes.

## Suggested wording for your Will:

 Provide your lawyer with the following sample language:

"I give [the residue of my estate], or [\_\_\_% of the residue of my estate] or [the sum of \_\_\_\_\_ dollars] or [a gift of this item 1 to ShelterBox New Zealand for its general purposes."

• Include this information:

You don't have to be wealthy to leave a gift. Even 1% of your estate will make a difference.
